Bills Introduced: 46 bills and 7 resolutions were introduced, as follows: S. 180-225; S.J. Res. 21-22; S. Con. Res. 3; and S. Res. 20-23.

Bill Rereferred: S. 2, to assist small business by allowing certain income tax deductions, which yesterday had been referred to the Committee on Banking and Currency was, by unanimous consent, rereferred to the Committee on Finance.

Electoral Count: Senate met in joint session with the House, pursuant to provisions of S. Con. Res. 1, providing for a joint session of the House and Senate in the Hall of the House on Friday, January 6, 1961, at 1 p.m., for the opening and counting of the electoral ballots of the several States for the election of the President and Vice President (for tabulation of votes see House Chamber).

After the Senate had returned to its Chamber Senator Hayden, one of the tellers on the part of the Senate appointed to count the electoral votes, announced the result of the count.

Senate Rules: At 2 p.m. upon the expiration of the morning hour, Presiding Officer laid down and Senate debated Humphrey motion to resume consideration of modified S. Res. 4, to amend rule XXII of the Standing Rules of Senate by permitting cloture on vote of three-fifths (rather than two-thirds) of Senators present and voting. Pending question at adjournment remained the modified Humphrey amendment (in nature of a substitute) to permit cloture by majority vote of Senators chosen and sworn (constitutional majority).

Witnesses heard were Joseph Meyer, of Todd Shipyards, New York; Moe Kirschenbaum, Industrial Relations Officer, and George P. Cross, Deputy Maintenance and Repair Officer, both of MSTS, Brooklyn; Paul E. Kamerick and Alfonse Calabrese, both of the committee staff; Henry C. Parks, Marine Electric Corp., Brooklyn; and Ralph Master, a former employee of Project Construction Co., Brooklyn.

Hearings were recessed until February 1.

Johnson, received 303 votes for President and Vice President, respectively, and Harry F. Byrd 15 votes for President. Richard M. Nixon and Henry Cabot Lodge received 219 votes for President and Vice President, respectively, Strom Thurmond 14 votes for Vice President, and Barry Goldwater 1 vote for Vice President.
